Amnesty International has learned that Ali Ardalan has been released.

The other men named above remain in detention. They were arrested on 31 May 1988 following the circulation of an open letter calling for an end to the war with Iraq. They are members of two organizations: the Association for the Defence of Freedom and Sovereignty of the Iranian Nation, and the Freedom Movement.

Amnesty International believes these six men to be prisoners of conscience and is calling for their immediate and unconditional release. Political detainees are not given access to legal counsel at any stage in their detention or trial. Prolonged incommunicado detention is common, and there are fears for the health of some of the above in view of their advanced age.

Further recommended action: Please send further telegrams/telexes/ airmail letters:

- welcoming news of the release of Ali Ardalan but expressing concern at the continued detention of the remaining six men above; urge that they be immediately and unconditionally released on the grounds that they are prisoners of conscience;

- urging that in the interim they be granted access to their families and medical doctors where necessary, and seeking clarification of their whereabouts.

Refer to relevant provisions in international law, such as the United Nations Universal Declaration of Human Rights:</p> <p>Article 3 — "Everyone has the right to life, liberty and security of person."</p> <p>Article 5 — "No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment."</p> <p>Article 9 — "No one shall be subjected to arbitrary arrest, detention or exile."</p> | <p>— The name of Amnesty International may be used, although letters written in a private or personal capacity may be more effective.</p> <p>— Copies of appeals should be sent to relevant diplomatic representatives in your country.</p> <p>— In Urgent Action cases, Amnesty International has to act rapidly to prevent the ill-treatment of prisoners.
