Amnesty International is concerned about the six men above, who were reportedly arrested on 31 May 1988, apparently after an open letter calling for an end to the war with Iraq was circulated. They are members of two organizations: the Association for the Defence of Freedom and Sovereignty of the Iranian Nation, and the Freedom Movement. Both organizations had reportedly been actively calling for an end to the war in recent days. Additional arrests are believed to have taken place.

The first five named above also held government or public office in the post-revolution provisional government of Dr Mehdi Bazargan, who leads the only legal opposition movement in Iran. Although Revolutionary Guards are believed to have called at Dr Bazargan's home in his absence, he is not among those who have been arrested.

Amnesty International believes the above to be prisoners of conscience and is calling for their immediate and unconditional release. Political detainees are not given access to legal counsel at any stage in their detention or trial. Prolonged incommunicado detention is common, and there are fears for the health of some of the above in view of their advanced age. Their whereabouts are unknown.

RECOMMENDED ACTION: Telegrams/telexes/airmail letters:

- expressing concern at the arrest of these six men and urging that they be immediately and unconditionally released on the grounds that they are prisoners of conscience;
- urging that in the interim they be granted access to their families and medical doctors where necessary, and seeking clarification of their whereabouts.

 - Article 3 "Everyone has the right to life, liberty and security of person.'
 - Article 5 "No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment.
 - Article 9 "No one shall be subjected to arbitrary arrest, detention or exile.'
