A prime rate of 12¼% before the end of the month is possible, analysts say, if pressures from sharp short-term interest-rate rises don't ease. A Fed panel voted on July 27 to push up the range of the federal funds rate, a base for determining other short-term fees, to 10½% to 10¾%. The Fed recently indicated it wants the rate as high as 11%.

ISRAEL'S CABINET opposed U.S. proposals for a new UN resolution.

The cabinet said it "rejects unequivocally" Washington's suggestion for Security Council language giving guarded support for Palestinian rights. The proposal, aimed at encouraging Palestinian participation in the peace process, "contradicts the commitment of the U.S. to Israel," a cabinet spokesman declared.

Later, U.S. Mideast envoy Robert Strauss emerged from a meeting with Prime Minister Begin, saying the U.S. will consider Israeli and Egyptian reservations before proceeding with the plan. The Security Council will take up the Palestinian issue this week.

Rejection of the UN initiative was another sign of the strain in U.S.-Israeli relations. Israeli officials are said to be pushing for a Carter-Begin summit to ease the tensions.

UN Ambassador Andrew Young, who resigned after a furor surrounding his meeting with a Palestine Liberation Organization official, said U.S. policy toward the PLO is "ridiculous." He said peace won't advance unless the U.S. opens communications with the PLO. But policy changes are being blocked.

CARTER USED his Mississippi River trip to plug his energy program.

A crowd in Alma, Wis., was urged by the President to "contact your own members of Congress" about supporting his program. He specifically mentioned his plan to tax the so-called windfall profits oil companies will make when price controls are lifted. Carter made a similar pitch in Prairie Du Chien, Wis., where he took questions from a radio audience.
